Statement regarding DC question number 2010030301, "Has a Succession Event occurred with respect to Northwest Airlines, Inc.?"

The ISDA Credit Derivatives Determinations Committee for the Americas (the "DC") has resolved to publish the following statement regarding DC question number 2010030301, "Has a Succession Event occurred with respect to Northwest Airlines, Inc.?" (the "DC Question").

Any capitalized term used and not defined in this statement shall have the meaning given to such term in the 2003 ISDA Credit Derivatives Definitions.

In reviewing the public information submitted to the DC related to the DC Question, the members of the DC believe based on Best Available Information that there is insufficient evidence to indicate that Northwest Airlines, Inc. (the "Reference Entity") had any Relevant Obligations outstanding at the time of its merger with and into Delta Air Lines, Inc. ("Delta") to which Delta could succeed.

The DC has resolved to suspend deliberation of the DC Question until March 31, 2010, being the 90th day after the event referenced in the DC Question. The purpose of this delay is to give market participants the opportunity to supply further Best Available Information to indicate whether Delta succeeded to any Relevant Obligations of the Reference Entity.

If any market participant would like to submit such Best Available Information, they should send it to NorthwestAirlinesInfo@isda.org as soon as possible, and no later than Tuesday March 30, 2010.
